MN Strategic ATV Master Plan Released

In December of 2019, acting as the Over the Hills Gang Club President and State Director for ATV Minnesota, I submitted and championed a resolution at the ATV Minnesota Legislative Summit to develop a statewide ATV masterplan. The resolution asked for \$250,000 from the ATVF Dedicated funds account to be allocated for the development of this plan and for an inventory of existing riding areas. This resolution became law under a larger MN Environment & Natural Resources appropriations bill.

As the ATV Minnesota State Director, a member of the Governors Outdoor Recreational Task Force, and personal experiences with being the project lead for the Emily/ Outing and Emily/ Blind Lake ATV trails, it was very apparent that ATV Riders were looking for connectivity, coordination & collaboration among local clubs, DNR, and local government units, education regarding ATV recreation, and a stewardship of the trails and overall environment. We all needed to think more strategically, and plan for the best use of the finite funds in the ATV dedicated account. Our state does not have an unlimited capacity for new trails, nor an unlimited capacity to maintain the trails we create. Bottom line, the ATV community needs to have strategic plans on how to grow our trail system, maintain what we create, and work with the communities and environment that can sustain ATV recreational activities.

Within the master plan there were survey questions asking about the most popular trail systems to ride. I am proud to say the Emily Outing system was named in the top three, along with Spider Lake and Nemadji. When questioned on best riding destinations, the Emily Outing Trail was rated #2, and the Emily Blind Lake Trail #7 in the entire state. This means tourism and economic input to our local communities. Another question asked about future interests, and many answered "the expansion of winter riding opportunities". Our club is one of the few that are working on expanding winter riding. I encourage our club members to take time to read this 107-page draft of the ATV master plan. It will provide you with a solid background of ATV Recreation today in Minnesota. The master plan will not get into specifics, as this is where belonging to a club will help answer more of your questions. I am personally excited about our Northwoods Regional ATV Trail Alliance and working within this alliance to grow, promote, and sustain all of the master plan direction & guidance.

New ATV Clubs



Northwoods Trail Alliance Expands

Two new ATV clubs, the Rapid Riders from Grand Rapids, and the Cuyuna Iron Range Riders

from Crosby/ Ironton were welcomed into the Northwoods Regional ATV Trail Alliance during the quarterly meeting of the alliance held on Wednesday January 15th in Aitkin, MN. The Rapid Riders manage the UPM Blandin Trail, and the Cuyuna Iron Range Riders manage the Miller Black-Bear and the Mississippi Northwoods ATV Trails. The alliance now has 11 member clubs managing over 500 miles of ATV trails across eight north central Minnesota counties. This alliance continues to grow in regional importance for ATV recreational trails and economic input to local trail towns.

 - Students Age 16 and older or born after July 1, 1987 must complete Online Safety Training course to apply for ATV Safety Certificate

Meet and discuss MN ATV Regulations with MN DNR Conservation Officer

Successfully complete your OnLine and Hands-On Safety Training and apply for MN ATV Safety Certificate (Need to be 12-years old to apply)
